CASS Bylaws Legal Review Update

- The draft Bylaws that were presented to the Board at its September meeting, and were recommended through motion for legal review, were evaluated by legal counsel Blair Maxston of Stillman LLP.
- Much of the feedback was in the area of technical edits, and recommended additions and deletions that would . make the Bylaws clearer and more succinct.
- Overall, the draft Bylaws received a favorable review and serves as a strong foundational start for the College. •

Code of Conduct for Professionals in K-12 Education

- Thank you to the zone directors and participating members who provided a significant amount of thoughtful commentary based upon a wide array of circumstances and contexts.
- Each zone's responses were collated and the effort to provide a common, concise, and clear set of recommendations to the Ministry was achieved. A report was shared with the Ministry for its consideration.

Criminal Record Check and Vulnerable Sector Check

Section 229 of the Students First Act provides leeway for immediate compliance given the following provision: Where a board is of the opinion that it is not possible for an individual to provide a criminal record check or vulnerable sector check, the individual must provide evidence that is sufficient for the board to determine whether the individual is suitable for employment in the position. Therefore, school authorities may be able to provide their own interim assurance mechanisms until such time that the completion of the checks are possible.

2021-2022 Audited Financial Report Presentation

The 2021-2022 Audited Financial Statement revealed CASS in good financial health, where revenues over expenses showed a surplus of \$106,782.00 of which \$41,032 is dedicated to the operations of the ARPDC. The audit findings indicate that the audit procedures did not reveal any significant deficiencies in internal control. The balances in the CASS Reserve Accounts as of July 1, 2022 are as follows:
