# Public Member Appointment for the CASS Board

- As stipulated in the CASS Act Section 7(1)(b)(i), it states that with 10 board members of the CASS Board, 1 public member will need to be appointed.
- Four qualified individuals were recommended and the Board through a ranking poll named a successful • candidate.
- This recommendation will be shared with the Minister and if the Minister accepts this recommendation, a formal announcement will be shared with members through CASS Connects.
- The term and compensation that would be provided for this position will be under the Minister's purview. •

#### ARPDC Provincial Leadership Position

- An interim leadership position as Provincial Executive Director who would operate as a CASS administrator for ARPDC was created.
- Having an employer to employee supervisory relationship with CASS and ARPDC is designed to generate a ٠ cohesive and productive relationship.
- The current ARPDC Executive Directors were invited to signify their interest in this role with a December 9, 2022 • deadline.
- At the Board's January meeting, the successful candidate will be recommended for appointment through a • formal motion.

#### CASS Board Policies and Administrative Procedures Manuals

- Given the legislated responsibilities of CASS as an organization and its duty to incorporate an effective governance structure to fulfill these responsibilities, a Policy Manual will be developed.
- Two foundational policies were presented which define the role of the Board and the role of the Chief Executive • Officer.
- Further policies will be developed, reviewed or considered, including a code of conduct, what substantiates a conflict of interest, and an oath of office, to name a few.
