### **APLC June Quarterly Update**

- The report highlighted APLC's work in supporting curriculum implementation through new committees, • professional learning, and collaboration with the Ministry.
- Operational updates include rebranding, communications, and technology use, while celebrations showcased . key initiatives like the Summer Symposium.

#### Literacy and Numeracy Screeners Update and Presentation

- Alberta Education Provincial Assessment representatives provided an update about the literacy and numeracy screening reports that will be available through the teacher dashboard.
- The Board was requested to provide feedback by June 23, 2025, for any enhancements to the reports. .

#### High School Course Catalogue Update

- A compiled report was submitted to the Ministry in response to a request to provide feedback about the High School Course Catalogue.
- The Board commended the platform's clean layout, intuitive navigation, and helpful features like course filtering and downloadable PDFs.
- Concerns include unclear access to Locally Developed Courses (LDCs), outdated links to legacy curriculum documents, inconsistent course categorization, and limited search filters for broad subject areas.
- Recommendations include clearer communication about LDC approval processes, enhanced filtering, and . consistent messaging for rollout. Suggested future improvements include AI-powered search, richer course resources, and direct LDC contact information.

#### **CASS Conditional Grant Interim Report**

- The grant supports provincial priorities, the Education Business Plan, and the implementation of the Leadership and Superintendent Leadership Quality Standards.
- The report highlighted the progress of the conditional grant deliverables as of May 15, 2025.
  - **System Leader Professional Practice** Advancements include leadership development, curriculum implementation, literacy, and school nutrition initiatives. Several projects are underway, with webinars, learning labs, and research in development.
  - Inclusive Education and Specialized Supports Projects aim to strengthen mental health supports and inclusive practices. A Communities of Practice pilot, educational assistant research, and eLeadership resources are progressing, with ministry collaboration.
  - First Nations, Métis, and Inuit Student Success The 2025 Education Gathering was held successfully. Planning is underway for future events and cultural learning initiatives, guided by the CASS First Nations, Métis and Inuit Education Committee.
  - **Career Pathways** The TAVE Committee has been revitalized to support skilled trades education, research studies, and the 2025 Trades and Technologies Summit.
  - **Collegiate Education** Foundations have been set to support Alberta's collegiate schools through networking, showcases, and ongoing resource development.
