

#### **Collegiate Schools**

- In partnership with publicly funded post-secondary institutions and industry partners, collegiate schools bring together students with similar interests to benefit from enriched programming, specialized facilities and enhanced learning opportunities through a unique delivery model.
- Collegiate schools offer specialized programming in a particular subject or field and provide all students with a clear pathway into post-secondary education and careers in their chosen field.



#### Collegiate Requirements

- Offer specialized programming in a specific subject/field.
- Partner with a publicly funded post-secondary institution and industry partner.
- Provide experiential learning opportunities/work experience and dual credit programming and/or bridging opportunities into post-secondary.
- Follow the Alberta programs of study.
- Ensure instruction is delivered by a certificated teacher or individuals with acceptable qualifications as determined by the Minister.
- Serve high school students.



#### **Optional Collegiate Components**

- Be scalable through online learning.
- Be part of a consortium consisting of multiple school authorities.
- Propose other flexible models to deliver collegiate programming.
- Offer additional learning opportunities outside of the Alberta Programs of Study.
- Serve junior high students.



#### **Collegiate Funding**

- Budget 2026
  - \$8 million in operational funding; and
  - \$21.5 million in capital funding.



Focuses on **place-based learning** to *FORGE FUTURES*, cultivate wonder, and expand possibilities through local partnerships and community diversity.



#### What does a partnership look like?

A level of shared responsibility, cooperation, planning and integration between the PSI and school.

Use of formal agreements outlining courses/credits to be offered, use of shared lab space or other facilities, access to instructors, development of shared curricula/resources, assessment practices and admission considerations.

Allows for flexibility and the ability to pivot to meet evolving labour market demands.




## **Alberta Youth and Driving**

- Alberta youth (15-24 years old) driver's license rates fall from 90% to 75% in 20 years
- Too many can miss out on apprenticeship programs, first jobs, and career growth
- Not having a license has a negative impact on career readiness
- Systemic impacts for Albertans and Alberta



## **Discovery Process**

- We talked to students, parents, teachers, and administrators from 30 Alberta schools
- They told us what might work:
  - Get cost down to \$50 or less (like other school fees)
  - Embed driving instructor subject matter expertise into online courses
  - Allow teachers to facilitate the courses as part of regular classes

- Target: Grade 8 or 9
- \$40 / student (school fee)




New Driver Online Program 2024

- \$40 / student (school fee)




